6. FAIR SERVICES

In order to apply for fair services, the Exhibitor must fill in the relevant form which must be submitted to the Organizer by September 05, 2023 at the latest. Orders submitted after this deadline will be satisfied according to the possibilities. The Organizer will charge 50% extra of the price list for orders of constructions and fair services placed by Exhibitor starting from period of the Fair preparation and work time (10-14.10.2023)

Standard stand constructed by the Estonian Fairs will be delivered to the Exhibitor starting from October 11, 2023, 9

If the Exhibitor chooses to construct a stand of own materials by the Exhibitor, an intended full layout of the stand incl electrical scheme must be submitted to the Organizer by September 20, 2023 at the latest to agree the layout and a required el. consumption. A list of people involved in the construction of the stand should be submitted to the Organizer before work in accordance with the prescribed fire-precautions and labor protection rules. The exhibitor should mount and dismount the stand within the time limits prescribed by the Organizer.

7. IDENTITY CARDS AND INVITATIONS

In proportion of the rented exhibition space identity cards will be issued to the Exhibitor from the info stand on October 11, 2023 as follows:

For additionally ordered identity cards and invitations 2,5 euro per each will be charged extra. The Exhibitor is entitled to get invitation cards free of charge according to the rented area as follows:

8. RENT OF AREAS AND STANDARD STENDS

9. PARKING CARDS

The Exhibitor will receive one parking card free of charge for the fair period. Extra parking cards are available at the info stand for 15 EUR and single entry for 5 EUR at the entrance to the fair territory on fair days.

10. TRADE FAIR CATALOGUE

Data of companies and organizations participating at the Fair, submitted to the Organizer by September 12, 2023 at the latest, will be published in the Fair Catalogue free of charge. The Organizer will supply the price list for additional advertising.

11. USE OF THE TRADEMARK

The Exhibitor is allowed to use the fair trademark in its own advertising and commercial activity only on the allowance of the Organizer.

12. WORKING ENVIRONMENT

13. TERMS OF PAYMENT

Confirmation of participation at the Fair and invoice for the participation fee will be sent to Exhibitor after receiving and accepting the properly filled Application Form. The invoice is to be paid within 10 days after registration at the Fair. If the payment is not provided in time the reserved area will be offered to a company on a waiting list. Contract will be terminated in accordance with tp. 14 of the present terms. An invoice for items stipulated in the application form will be sent to the Exhibitor after the due date of registration. The Exhibitor is obliged to provide payment within 10 days. An Invoice for additional fair services, also for those placed during the exhibition layout or exposing period will be issued by the Organizer after the closing of the Fair.

14. TERMINATING THE CONTRACT

The Exhibitor is entitled to cancel all reservations prior to September 20, 2023 bearing no sanctions. Cancellations made between September 20, 2023 and September 30, 2023 are subject to participation fee. Reservations cancelled after September 30, 2023 are subject to any charges which have already fallen due, incl. all participation, standard stand or exhibition space rental fees in full.
